- Food vendors MUST provide a completed Placer County Environmental Health Department form to the Lincoln 4th of July Foundation with application.
- Vehicles are allowed in the vendor area only during setup and clean up times.
- Vendor vehicles must display the appropriate parking pass at all times.
- Electrical access is not available. Vendors are responsible for providing their own generator(s) to meet their electrical needs. Silent generators are preferred, but not required.

- To qualify for non-profit rate, you must meet the following criteria: Provide a valid non-profit identification number. You must be based in Lincoln. Your organization must be composed of at least 51% Lincoln residents.
- To qualify for the youth rate, the youth organization must be based in Lincoln and composed of at least 51% Lincoln residents.
- Advance payment of all fees is required when application is submitted.

Please make sure your permits are up to date. Placer County has in fact attended our event in the past to check permits.
